Annual Business Meeting

Massachusetts Fruit Growers' Association, Inc.

Sturbridge Host Hotel, Sturbridge, Massachusetts January 5, 2000

The Annual Business Meeting was called to order at 11:50 AM by President David Bishop. President Bishop offered words of welcome to the membership. Twenty-five individuals were present.

Secretary's Report

The Annual Business Meeting of the Massachusetts Fruit Growers' Association, Inc. was held on January 6, 1999. Twenty-seven members attended. Directors met on March 24, July 21, and December 1, the Executive Committee met on May 26, and the Trustees of the Horticultural Research Fund met on July 14. The Annual Summer Meeting was on July 21 at Wellsmont Orchards in Shelburne. Approximately 100 individuals attended the meeting.

One-hundred and eighty-five individuals were members of the Association in 1999, a slight increase from 1998. Below are the membership figures for 1995-99.

Treasurer's Report

The General Fund began the year with a balance of \$24,264.55. To date, receipts totaled \$50,628.23, and disbursements totaled \$45,883.35. The balance on December 31 was \$29,009.43. Please note that the expenses of printing and mailing the *Proceedings* have not yet occurred. The Horticultural Research Fund began the year with a balance of \$171,570.92. A total of \$2,500 was moved into the Horticultural Research Fund from the General Fund, and \$1,419.65 was expended on a grant. The balance as of December 31 was \$171,229.90. Over the year, the Horticultural Research Fund lost 0.8%, excluding moneys added from the General Fund and disbursements on grants. Issues regarding the balance in the endowment that we established with the University of Massachusetts

Foundation have not yet been resolved. Letters have been written to the Director of Development, the Chancellor of the University of Massachusetts at Amherst, and the President of the University of Massachusetts, with no response to date.

Auditor's Report

Nicewicz introduced Kip Graham who discussed the potential availability of disaster relief money. Nicewicz also introduced Rick Lablanc who discussed apple promotion billboards.

Nomination Committee Report

Autio presented the report of the Nominations Committee. Bill Broderick was nominated for President. Tim Smith, Ken Nicewicz, and Kim Wiezbicki were nominated for Vice Presidents. Wes Autio was nominated for Secretary and for Treasurer. Bob Davis was nominated for Auditor. Rick Bartlett, Frank Carlson, Bill Fitzgerald, Mario Lanni, Tony Lincoln, Robin Spitko, Mo Tougas, and Steve Ware were nominated to fill six Director positions (four 3-year terms and two 2-year terms). The report was accepted, and no further nominations were received from the floor. Ballots were distributed and all nominated officers were elected. Carlson, Lincoln, Tougas, and Ware were elected as Directors for three years, and Bartlett and Lanni were elected as Directors for two years..

President Bishop passed the gavel to the new president, Bill Broderick. The meeting was adjourned at 12:40 PM.
