

**Minutes**  
**Meeting of the Board of Directors**  
**Massachusetts Fruit Growers' Association, Inc.**  
*Old Mill Restaurant, Westminster, Massachusetts*  
*March 9, 2004*

The meeting was called to order by President Nicewicz at 1:15 PM. Individuals present were Wes Autio, Bill Broderick, Frank Carlson, David Chandler, Tom Clark, Jon Clements, Carl Damateo, Bob Davis, Alex Dowse, Kip Graham, Duane Greene, Tony Lincoln, Ken Nicewicz, Doug Reid, Bob Smiley, and Steve Ware. Nicewicz gave words of welcome.

***Secretary's Report***

Autio presented the minutes of the December 3, 2003 Directors' Meeting. It was moved, seconded, and passed to accept the minutes as presented.

***Treasurer's Report***

The General Fund began the year with a balance of \$32,963.11. Receipts to date totaled \$16,040.71, and disbursements totaled \$7,851.23. The balance on March 9, 2004 was \$41,152.59. The Horticultural Research Fund began the year with a balance of \$438,664.18. A total of \$4,084.72 in receipts and \$293.43 in expenses have occurred to date. The balance on March 9, 2004 was \$463,606.67. So far in 2004, the Horticultural Research Fund has gained 5.7% of its value. The Treasurer's Report was moved, seconded and passed.

***Committee Reports***

Trustees of the Horticultural Research Fund, Annual Meeting Facilities, Legislative, Cider, UMass Fruit Advisory, Harvest Labor, and Marketing committees reported. Carl Damateo from Massachusetts Farm Bureau, Doug Reid from the College of Natural Resources & the Environment Development Office at UMass Amherst, and Kip Graham from Worcester County USDA Farm Services Agency contributed to the various discussions of these committees. Much discussion ensued.

***Old Business***

Davis reintroduced efforts to enhance endowments in support of the UMass Cold Spring Orchard Research & Education Center. Autio presented a 10-year budget projection comparing current membership practices to using a 10-year free membership as an incentive to donate to the endowment.

**Motion:** *The Massachusetts Fruit Growers' Association, Inc. supports the effort to build and endowment in support of operations at the University of Massachusetts Cold Spring Orchard Research & Education Center. The motion was seconded and passed unanimously.*

active membership to any individual donating \$2,500 to the endowment in support of operations at the University of Massachusetts Cold Spring Orchard Research & Education Center. The motion was seconded and passed unanimously.
