The General Fund began the year with a balance of \$40,558.02. Receipts to date totaled \$360.19, and disbursements totaled \$3,083.26. The balance on March 15 was \$37,834.95. The Horticultural Research Fund began the year with a balance of \$295,502.13. A total of \$0.70 in receipts ha2 occurred to date. The balance in the Horticultural Research Fund on March 15 was \$303,843.28. So far in 2011, the Horticultural Research Fund has gained 2.8% in value. The Treasurer's Report was moved, seconded and passed unanimously.
