Annual Business Meeting

Massachusetts Fruit Growers' Association, Inc.

New England Vegetable & Fruit Conference, Manchester, NH December18, 2013

The Annual Business Meeting was called to order at 12:25 PM by President Andrew Martin. President Martin offered words of welcome to the membership. Approximately 35 members were present.

Secretary's Report

One hundred and nineteen individuals paid membership dues in 2013. An additional 27 had previously committed to the 10-year-membership/matching program with the Massachusetts Society for Promoting Agriculture and the Commonwealth. Their active membership will continue through 2015. Below are the membership figures for 2006-13.

The Annual Business Meeting was on January 17, 2013, at the UMass Cold Spring Orchard, Belchertown, MA, and the Annual Summer Meeting was on July 10 at Honey Pot Hill Orchard in Stow, MA, with approximately 130 people in attendance. The Board of Directors met on March 21 and December 6, 2013.

Treasurer's Report

The General Fund began the year with a balance of \$48,555.35. Receipts totaled \$32,266.33, and disbursements totaled \$29,458.05. The balance on December 31, 2013 was \$51,363.63. The Horticultural Research Fund began the year with a balance of \$328,653.29. A total of \$300.35 was received in 2013. The balance in the Horticultural Research Fund on December 31, 2013 was \$392,902.21. In 2013, the Horticultural Research Fund gained 19.5% in value. The Treasurer's Report was moved, seconded and passed. Details follow on the next page.

Ken Nicewicz, the Auditor, reported that the Treasurer's Report was complete and accurate as presented. The Auditor's Report was moved, seconded, and passed unanimously.

Other Business

The Marketing (Nicewicz), Legislative (Dowse), UMass Fruit Advisory (Carlson), Prokopy Fund (Nicewicz), and Harvest Labor (Carlson) Committees and Trustees of the Horticultural Research Center presented brief reports. Lisa Damon reported briefly on the Farm to School Program.

Nominations Committee Report and Elections

On behalf of the Nominations Committee, Autio presented a slate of candidates for officers and directors, including Al Rose for President, Glenn Cook, Joann Dinardo, and Ben Clark for Vice Presidents, Wes Autio for Secretary and Treasurer, Ken Nicewicz for Auditor, and Tom Clark, Pat Kriksceonaitis, Jonathan Morse, Mark Parlee, Chris Smith, Mark Tuttle, and Joel O'Toole for Directors. No additional nominations were received from the floor. Nominated candidates for president, vice president, secretary, treasurer, and auditor were elected. Tom Clark, Mark Parlee, Mark Tuttle, and Joel O'Toole were elected as directors for 3 years, and Pat Kriksceonaitis was elected to serve 2 years.

The meeting was adjourned at 12:45 PM.
