Minutes

Annual Business Meeting Massachusetts Fruit Growers' Association, Inc. New England Vegetable & Fruit Conference, Manchester, NH December 16, 2015

The Annual Business Meeting was called to order at 12:20 PM by President Al Rose. President Rose offered words of welcome to the membership. Approximately 30 members were present.

Secretary=s Report

One-hundred and five individuals paid membership dues in 2015. An additional 27 had previously committed to the 10-year-membership/matching program with the Massachusetts Society for Promoting Agriculture and the Commonwealth. This program ends this year. The Annual Business Meeting was on January 14, 2015, at the UMass Cold Spring Orchard, with about 50 members in attendance. Directors' Meetings were held on March 25 and December 9 at the Old Mill Restaurant in Westminster, MA. The Annual Summer Meeting was held at the Red Apple Farm in Phillipston, MA, with about 120 individuals in attendance.

Treasurer=s Report

The General Fund began the year with a balance of \$58,486.12. Receipts totaled \$39,098.51, and disbursements totaled \$33,999.53. The balance on December 31, 2015 was \$63,585.10. The Horticultural Research Fund began the year with a balance of \$390,093.35. A total of \$51,311.41 was disbursed in 2015. The balance in the Horticultural Research Fund on December 31, 2015 was \$322,319.45. In 2015, the Horticultural Research Fund lost 17.4% in value. The Treasurer=s Report was moved, seconded and passed. Details follow on the next page.

Ken Nicewicz, the Auditor, reported that the Treasurer's Report was complete and accurate as presented. The Auditor's Report was moved, seconded, and passed unanimously.

Other Business

Several committees gave very brief reports. No new business was offered.

Nominations Committee Report and Elections

On behalf of the Nominations Committee, Autio presented a slate of candidates for officers and directors, including Glenn Cook for President, Joann Dinardo, Ben Clark, and Chris Smith for Vice Presidents, Wes Autio for Secretary and Treasurer, Ken Nicewicz for Auditor, and Bill Broderick, Alex Dowse, Pat Kriksceonaitis, Andrew Martin, Chelsea Martin, and Sean O'Neill for Directors. No additional nominations were received from the floor. Nominated candidates for president, vice president, secretary, treasurer, and auditor were elected. Bill Broderick, Alex Dowse, Pat Kriksceonaitis, and Andrew Martin were elected as directors for 3 years.

The gavel was passed to the new president, Glenn Cook, who offered a few words and thanks. The meeting was adjourned at 12:45 PM.
