Minutes of the December 13, 2017 Annual Business Meeting

Directors' Meetings were held on April 4 and December 5 at the Old Mill Restaurant in Westminster, MA. The Annual Summer Meeting was held on July 10 at UMass Cold Spring Orchard, Belchertown, MA, with about 120 individuals in attendance.

Treasurer=s Report

The General Fund began the year with a balance of \$74,100.78. Receipts totaled \$36,959.95, and disbursements totaled \$24,742.68. The balance on December 31, 2018 was \$86,318.05. The Horticultural Research Fund began the year with a balance of \$295,344.08. A total of \$51,231.64 was disbursed in 2018. The balance in the Horticultural Research Fund on December 31, 2018 was \$217,846.27. The Treasurer=s Report was moved, seconded and passed. Details follow on the next page.

Ken Nicewicz, the Auditor, reported that the Treasurer's Report was complete and accurate as presented. The Auditor's Report was moved, seconded, and passed unanimously.

Other Business

Several committees gave very brief reports. No new business was offered.

William Broderick, Pat Kriksceonaitis, Alex Dowse, and Andrew Martin were elected as directors for 3 years.
